FY 17 Amended Budget Approved

Board approval was given to the fiscal year 2017 amended final budget. The general fund appropriation is \$3,304,305; the total appropriation is \$4,752,866. The total appropriation also includes governmental program, food service, capital projects, insurance reserve, preschool, pupil activity and bond redemption.

Board Resolution for 4-Day School Week Pilot Program

The resolution approved expresses support of beginning a 3-year pilot program and move to a 4-day week schedule for a trial period beginning with the 2017-18 school year. The resolution stated various factors contributing to the board's decision and spells out areas to be assessed and evaluated at the end of the pilot program. Results of the evaluation will determine whether a 4-day schedule will continue. The board anticipates reviewing a draft 2017-18 calendar at their February board meeting.

Employment

The employment of Substitute Teacher, Billie Culp was approved along with Extra Duty Pay Agreements for Coaches Ubaldo Aguilera and Clint Mondragon.

Board Policy Revisions

Revisions to policies IKF and IKF-2 Graduation Requirements were approved for second reading and adoption. The changes will be phased in and will provide measures and cut scores/criteria for assessments, concurrent courses and other areas such as industry certificates and capstone projects. Work will be on-going to create regulations to the policies and establish implementation.

Other Items

The board also approved minutes of previous meeting and financial reports for December.

Discussion Items

The board discussed the process for evaluation of the superintendent and schedule for administrator evaluations. Also discussed were ideas to improve communication and create options for all parents, with consideration of out-of-district parents, to create opportunities to provide input. Options may include committee meeting times more convenient to parents or informal events for parents and board members.

Resolution for Four-Day School Week Pilot Program

Whereas, the Mill Levy Override, proposed by the Board of Education in order to increase revenue, failed to get enough votes from the Sargent School District community to pass and that the said mill levy was brought before the community voters twice, and

Whereas, the" Negative Factor", Budget Stabilization Formula from the State of Colorado, is increasing which reduces the operational revenues of the Sargent School District, and

Whereas, the Sargent School District has already spent down their surplus reserves to the limit established by policy, and

Whereas, the actual number of students attending Sargent School District has been decreasing, which reduces the revenue that Sargent School District receives form the State of Colorado, and

Whereas, this lack of adequate revenue limits Sargent School District's ability of being competitive in the hiring, maintaining and increasing the salaries of teachers and staff, and

Whereas, going to a four-day school week will reduce some of the operating expenses and thereby increase the revenue of the Sargent School District, and

Whereas, the majority of students, that attend Sargent School District, along with their parents have voiced their personal desire of a four-day school week, and

Whereas, the majority of other school districts ,in our local area and that we face through competitive programs, are also on a four-day school week therefore, our scheduling conflicts should be reduced , and

Whereas, the Administration of Sargent School District believes that the student academic standards as well as student and teacher morale will not decrease but should increase with the four-day school week, and

Whereas, the Administration of Sargent School District believes that going to a four-day school week will keep and attract more students as well as reduce the absenteeism of the students to the Sargent School District,

Therefore, be it resolved, that Sargent School District will go to a four-day school week, for a period of three years, beginning with the 2017-18 school year. During the spring of the 2019-2020 school year the Sargent Board of Education will reevaluate the four-day school week program to determine if our academic standards are still being met, if we have maintained our level of accreditation, if the morale of students and staff has improved, if the atmosphere of our learning environment has improved, the number of students has been steady or increased, the absenteeism has been reduced, and if our financial situation has changed. It will be the responsibility of the Board of Education, at that time, to determine whether or not to stay with a four-day school week or revert back to the traditional five-day school week for the 2020-2021 school year. This resolution will expire upon completion of said vote.
